- Students, if the editorial board deems it fit to be an extraordinary scholastic work.

Research paper should be thematic and identification of sub-themes will be highly appreciated. It should have proper research questions and should also reflect the findings. The submission can be sent under the following categories:

**1. Research Paper/ Article:** Between 7000 and 10000 words, inclusive of footnotes. Papers in this category are expected to engage with the theme comprehensively, examine literature accordingly and offer an innovative reassessment of the current understanding of that theme. It is advisable, though not necessary, to choose a theme that is of contemporary importance. Purely theoretical pieces are also welcome.

**2. Notes and Comments:** Between 3000 and 5000 words, inclusive of footnotes. This section should include a thought provoking and innovative piece consisting primarily of personal opinions and analysis.

**3. Case/Report Comments:** In between 2500-3000 words, inclusive of footnotes. This part should entail an analysis of contemporary Indian or International judicial pronouncements relevant to the contemporary legal world. It must identify and examine the line of cases in which the decision in question came about, and comment on implications for the evolution of that branch of law.

**4. Literature Review:** Word limit is 2000- 3000 for review of a book relevant to the contemporary legal literature. The review should identify the relevant arguments put forth by the author and present a comprehensive analysis of the same.

### **Guidelines for Submissions:**

- Submissions should be in Times New Roman (Font), 12 Font size with 1.5 line spacing, Text justified, 0.5 inch para indentation and 1inch/2.54cm margin on all sides of A4 size.
- Footnotes should be in Times New Roman, 10 Font size with 1.0 line spacing and Text justified. Scholars are strictly advised to close all the foot notes. Endnotes are not allowed. Foot note text and the number (no superscript) should be in Times New Roman. The author(s) name in the text and about the author in the foot note shall be symbolised (Author's name\* and co-author's name\*).
- Graphs, Charts, Tables, and Diagrams should be numbered consecutively and included in the body of the paper. Submission must be compatible with MS Word.

- **LEVEL-1 TITLE OF THE PAPER:** UPPER CASE, **Bold**, Times New Roman, 12 Font size and Center aligned;
- **LEVEL-2 Heading:** Title Case (Sentence Case), **Bold**, Times New Roman, 12 Font size and left aligned; and
- **LEVEL-3 Sub-Heading:** *Title Case, Bold*, Times New Roman, 12 Font size, *Left aligned and Italic*.

The covering letter should include the author's, designation, institutional affiliation along with contact information and an abstract of not exceeding 200 words along with 4 to 6 key words.
- The submission must be the original work of the author(s). Any form of plagiarism (not more than 15% in total and 10% from one source in the main body of the paper) may lead to disqualification.
- Co-authorship is allowed but not more than one.
- The shortlisted contributors will be informed by **August 30, 2018**.
- Copyrights of shortlisted contributors for publication shall be with MNLU, Nagpur.
- The Journal is likely to be released in the month of October 2018.
- A hard copy of published issue as well as a letter of acknowledgement shall be sent to the contributors.
