- b) who have completed any course on IPR from RGNIIPM Nagpur and must upload evidence/certificate for the same from Institute

- Motivation letter for Summer School (reason for applying & what is expected to be gained from the Summer School - Maximum 300 words)
- Recent Curriculum Vitae/Resume
- Identification documents such as Passport or National ID
- Exceptions/ DL101 Course Certificate (distance learning 6 week free online WIPO course)
