Maharashtra National Law University, Nagpur invites applications against Vacant Seats for B.A.LL.B. (Hons.) Five-Year Integrated Degree Course. **Those Candidates who have appeared CLAT-2022 are only eligible to apply under the Vacant Seats**.

## **Number of Vacancies:**

**General-05** (Those who have secured All India Rank upto 3500 are eligible.) **OBC** (**MH**)-**04** (Those who have secured Category Rank upto 10000 are eligible)

1) Interested candidates are required to apply through the link provided. No other mode of application shall be accepted. Candidates can apply by clicking on this link at <a href="https://erp.nlunagpur.ac.in/">https://erp.nlunagpur.ac.in/</a>

- 2) Candidates who have sent Expression of Interest earlier are also required to apply.
- 3) Admission against vacant seats are made only as per the Merit List prepared against this application procedure.
- 4) The Last Date for Application against Vacant Seats is **September 1, 2022 till 11:59 p.m.** Applications received after the above mentioned time frame will not be considered for preparation of Merit List.
- 5) The Merit list will be notified on the website of the University as well as it will be communicated to the selected Candidates on **September 2, 2022 (Friday)**.
- 6) The candidates whose name appears in the Merit list will be required to pay the Annual Fee for the Academic Year 2022-23 i.e. Rs.2,60,000/- (Rupees Two Lakhs Sixty Thousand Only) on or before September 5, 2022 (Monday) by 4:00 p.m. The Payment can be made through the ERP Portal i.e., <a href="erp.nlunagpur.ac.in">erp.nlunagpur.ac.in</a> or by transferring the amount electronically to Current Account No. 35882247161 State Bank of India, Ravi Nagar Branch, Nagpur IFSC Code—SBIN0007504, MICR Code—440002015 (Receipt of Payment shall be sent to <a href="mailto:accounts@nlunagpur.ac.in">accounts@nlunagpur.ac.in</a>).
- 7) If the candidate (whose name appears in the Merit list) fails to transfer the fee on or before **September 5, 2022 (Monday)** by **4:00 p.m.**, then his / her candidature will be dropped from the Merit list.
