About the University

Maharashtra National Law University, Nagpur (MNLU, Nagpur) was established by the Government of Maharashtra by way of enactment known as the Maharashtra National Law University Act (Maharashtra Act No. VI of 2014). Hon'ble Shri Justice Bhushan R. Gavai, Judge, Supreme Court of India, is the Chancellor of the University. It is a residential University engaged in teaching and promoting research in law and allied disciplines. The University is making all possible efforts to bring up state-of-the-art facilities. The University has a competent team of faculty members and staff, who are qualified, experienced, committed, and full of zeal to create an institution of excellence in legal education in the country.

The University has been recognised by the University Grants Commission (UGC), it received necessary affiliation from the Bar Council of India (BCI), and it is also a member of Association of Indian Universities (AIU). The objectives of the University are manifold: to advance and disseminate learning and knowledge of law, legal processes and their role in national development; to serve society in the field of law by developing skills in regard to advocacy, legal services, legislation, law reforms and the likes; to promote legal knowledge and to make law and legal processes efficient instruments of social justice and development; to promote traditional, cultural, legal and ethical values with a view to promote and foster the rule of law and the objectives enshrined in the Constitution of India; and to liaison with institutions of higher learning and research in India and abroad.

At present, the University is offering three Undergraduate Degree Courses and a One-Year Postgraduate Degree Course in Corporate and Commercial Laws; Intellectual Property Law and Policy; Constitutional Laws; Personal Laws; Energy and Telecommunication Laws; and Criminal Law and Forensic Sciences, in addition to the Ph.D. Programme. The University has also expanded its horizon with varied field of knowledge by collaborating with various institute of excellence from diverse disciplines and introducing novel course such as B.A.LL.B.(Hons. in Adjudication and Justicing) Five-Year Degree Course, which is designed to disseminate quality justice education among the students and extend support to the justice administration system in the country.

About the Course

The University is determined towards its commitment for continuous development in the field of legal and justice education with its competent and professional team of students, faculty members, administration, and collaborations. However, the University also recognises that there are individuals who could not complete their higher education in Law as first preference or first degree, due to various reasons. Therefore, the University is offering a Non-Residential **One-Year Executive LL.M. (Postgraduate) Degree Course** with multidisciplinary approach towards laws and other disciplines of knowledge for the executives. It is an attempt to spread out the quality legal education to those who could not obtain or continue with their higher education in Law owing to personal, financial, and/or professional commitments.

Eligibility

- Three (3) years or five (5) years Bachelor's Degree in Law (LL.B.) or an equivalent degree with a minimum of Fifty (50) percent marks or its equivalent grade from a recognised University/Institution of higher education in case of candidates belonging to General/OBC/PWD categories and Forty-Five (45) percent marks or its equivalent grade from a recognised University/Institution of higher education in case of candidates belonging to SC/ST categories.
- No Upper age Limit.

Admission Process

Eligible Candidate will be admitted to the course as per the merit cut-off list of Entrance Test conducted by the University.

Duration of the Course

- The Course is offered for a period of an Academic Year starting from October 2023 to September 2024.

Mode of Conduct

- Classes will be conducted in hybrid mode (online and physical).
- Classes will be conducted only on Saturdays, Sundays, or Evening on Weekdays.

Total Number of Seats

The total number of seats are 60. However, the University reserves the right to alter the number of seats for the course in the given Academic Year without prior notice.

Reservation Policy

The reservation policy of the University followed for the existing offered Courses will be applicable to the Course. The total intake and reservation matrix is as following:

Course Structure

The Course is of Twenty-Four (24) Credits comprising of: Four (4) Mandatory Papers of three (3) credits each, and Six (6) Elective Papers of two (2) credits each. The students would be allowed to choose three 3 subjects in each semester out of the offered list of electives.

Fee Structure

Application Fee (Non-Refundable): Rs.2,000/- (Two Thousand Rupees Only).

Course Fee: Rs.1,51,000/- (One Lakh Fifty-One Thousand Rupees Only).

The Course fee is inclusive of admission fee, tuition fees, and library. It does not include lodging and boarding charges.

Refund Policy: If the candidate opt to cancel the admission and communicate the same to the University within Ten (10) days from the date of admission, full refund of fee after deducting administrative charges shall be made. However, no refund shall be made after the given period of Ten (10) days.
