GUIDELINES FOR SUBMISSION OF ABSTRACT AND FULL PAPER

- The Abstract shall not exceed 300 words. The length of the full paper including tables, diagrams, illustrations, references, etc. shall not be less than 3000 words and shall not exceed 6000 words.
- The abstract and full paper should be in Times New Roman, font size 12, with 1.5-line spacing, and footnotes in Times New Roman, font size 10, with single-line spacing.
- The texts and footnotes must conform to the ILI Citation Style.
- The Abstract should be followed by an outline of the Article with a brief Discussion.
- The submission of abstract must be in (.doc) or (.docx) only. The submission should contain a disclaimer to the effect that the piece is original and has not been published or is under consideration, for publication, elsewhere. All submissions are subject to a Plagiarism check.
- Upon selection, the participants shall submit the full paper. The abstracts will be peer-reviewed by the organizing committee and only shortlisted abstracts will be invited to submit final papers.

- Participants/Paper Presenters have to register on the given link after the acceptance of abstract with payment of required fees.
- The final paper should be submitted after the intimation of acceptance of abstract. No abstract or full paper shall be accepted after the last dates of submission, respectively.
- For participation, registration is mandatory on the acceptance of abstract. Only registered participants will be allowed to take part in the Seminar.

IMPORTANT NOTE:

- The abstracts will be peer-reviewed by the organizing committee and only shortlisted abstracts will be invited to submit final papers.
- The final paper should be submitted after the intimation of acceptance of the abstract.
- Co-authorship is permitted to maximum two authors. Each author is required to register and pay the registration fee individually.
- The selected papers will be published in a peer-reviewed e-journal of MNLU, Nagpur.
- Registration is mandatory to participate or attend the Seminar.
- Certificate will be awarded to the registered participants and Seminar attendees who attend all the sessions of the.
