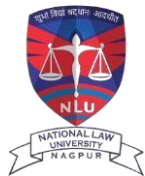

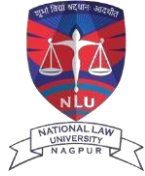

Residential Campus Information

The University provide **pick-up and drop transportation** between the Extended Campus and the Main Campus for academic and other University-related activities.
