Concept Note: In today's globalising world, the means and modes of education are developing with the technological advancements. The role of a teacher, in the existing setup wherein the quality of education and research has become debatable, becomes more important. A teacher does not only impart knowledge but is a 'Knowledge-creator'. He/she is an architect, who shapes the personality of the students. Knowledge creation is a paramount duty of the individual towards the society, nation and the entire humanity. The concept of knowledge should not be limited to only the black texts and expressions thereof; it should enlighten the lives of the students with wisdom. **Rig Veda** says, "*The intelligent man on the basis of his knowledge becomes powerful and great just as intake of food gives energy and strength*". The teachers have to preserve this knowledge in a similar way as we preserve the energy. The ultimate aim of the knowledge preservation is for passing it to the coming generations and the successors owe pious obligation to add therein and passing off to next generations.

Knowledge- 'Creation', 'Preservation' and 'Succession' process involves various concepts, issues and challenges which need to be addressed and resolved in the light of past experiences, present needs and future hopes. This perspective possesses an immense value for the academicians from different fields in performing their individual, social and professional responsibilities. Considering the immense importance of the knowledge dissemination towards achieving the aims of the National IP Policy, the DPIIT-IPR Chair and Centre for Intellectual Property Rights, of Maharashtra National Law University, Nagpur proposes a 'Faculty development program on Intellectual Property Rights to orient and train the teachers from different streams with different facets of Intellectual Property Rights The workshop aims at providing fundamental background on Intellectual properties which include Patents, Copyrights, Designs, Trademark etc. The participants would understand how to make use of the technology transfer offices (IPR Cell) within the university, to protect and commercialise IP generated through research. This program is aimed at acquainting faculties with the modalities of Intellectual Property Rights (IPR) by way of focusing on application of IPR in Law, Management and Media, Engineering & Technology, Pharmacy, Architecture, Applied Arts & Crafts.

About the University: The Maharashtra National Law University, Nagpur, an Institution with a students' centric outlook, was established by the Government of Maharashtra in 2015. The University started its activities from August 1, 2016 and soon entering in its sixth year of academic pursuits with five batches of undergraduate degree course [B.A.LL.B.(Hons.) Five-Year Integrated Degree Course]; fifth batch of postgraduate degree program [One-Year LL.M.]; and three batches of Ph.D. programme. The University is pursuing excellence in legal and justice education under the visionary mentorship of the Chancellor, Hon'ble Shri Justice Bhushan Gavai, Supreme Court of India and dynamic leadership of Prof. (Dr.) Vijender Kumar, Vice-Chancellor of the University. It is also a member of Association of Indian Universities (AIU), New Delhi and Consortium of National Law Universities of India. The University has launched B.A.LL.B. (Honors in Adjudication and Justicing) Five-Year Integrated Degree Course, the first-of-its-kind in India; it aims to train and equip students for the entry level of Judiciary.

The objective of the University are manifold mainly, to advance and disseminate learning and knowledge of law and legal process as an efficient instrument of social justice and national development; to develop the sense of responsibility within the students and research scholars; to serve the society by developing various skills and knowledge of legal principles aimed to promote traditional, cultural, legal and ethical values with a view to promote and foster the rule of law and the objectives enshrined in the Constitution of India. In order to achieve the objectives, the University has established twenty- eight centres for advanced legal studies and research in different fields of law to address the socio-legal issues and challenges and to conduct cutting edge research on thriving issues of law, social science and humanities.

About the Centre: The Centre for Intellectual Property Rights (CIPR) is one of the Advanced Legal Research Centre of the University intending to promote the Human, Social and Commercial values through exclusive socio-legal research in the field of Intellectual Property Rights. The University is proud to have the DPIIT-CHAIR on Intellectual Property Rights established by the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India. IPR is an evolutionary field. IPR provides an incentive for creativity and the disclosure of information and plays a significant role in encouraging innovations in the form of product/process development leading to technical advancement. Therefore, knowledge about IPR becomes essential in all the fields. Effective Intellectual property (IP) protection has been a critical factor; however, academia is playing a serious catch-up to create awareness of IP.
