#### INSTRUCTIONS FOR COMPLETION OF ADMISSION FORMALITIES

1. Candidates are strictly advised to follow the procedure prescribed by the CLAT 2021 Office for completing the Admission formalities.
2. Candidates who were been allotted to Maharashtra National Law University, Nagpur and have locked their option to remain with Maharashtra National Law University, Nagpur and have paid Rs.50,000/- to CLAT 2021 Office are only required to pay First Instalment of Annual Fee for the Academic Year 2021-22 i.e. **Rs.46,500/- (Rs.37,125/-** in case of Candidates of Maharashtra Domicile). **Note:** Hostel Charges and Mess Fee are not collected along with the First Instalment. The same will be collected as and when the University re-opens for Physical Classes. A separate communication to this effect will be sent to the parents in due course of time.

3. Candidates are required to upload scanned copies of the following documents at Consortium of NLUs website for completion of Admission formalities at Maharashtra National Law University, Nagpur

  - Maharashtra Domicile Certificate (for Maharashtra Residents)
  - Conduct / Character Certificate
  - Transfer Certificate
  - Migration Certificate
  - Caste Certificate issued by the Competent Authority (wherever applicable)
  - Caste Validity Certificate Issued by the Competent Authority
  - Non- Creamy Layer Certificate (wherever is applicable)
  - EWS Certificate (wherever applicable)

➤ SAP/PWD Certificate (wherever applicable)

**Note:** The Specially Abled Persons (Persons with Disability) should upload the Disability Certificate issued by the Competent Authority, i.e., District / State Medical Board during the last five years. The candidates will be considered under the said category only when the percentage of disability is 40% and above. Acceptance of their Disability Certificate by any other CLAT participating University would not automatically entitle them for admission under the said category at Maharashtra National Law University, Nagpur.

- 4 The candidates belonging to SC, VJ/DT (NT(A)), NT(B), NT(C), NT(D), OBC and SBC categories should produce “Caste Validity Certificate” issued by Scrutiny Committee of Social Welfare Department and the Candidate belonging to ST category should upload “Tribe Validity Certificate” issued by Scrutiny Committee of Tribal Department.
- 5 The candidates belonging to VJ/DT (NT(A)), NT(B), NT(C), NT(D), OBC and SBC categories should upload “Non Creamy Layer Certificate” issued by Sub Divisional Officer / Deputy Collector of the district in addition to the caste certificate.
- 6 All candidates must produce the originals of the above mentioned documents when the University resumes physical academic activities, till then the admission remains provisional.
